→ Prevenirea riscurilor posibile si a situatiilor de urgenta.

→ Actionarea în directia îmbunatatirii continue a performantelor noastre de mediu si reducerea astfel a impacturilor de mediu negative rezultate din activitatile, procesele, produsele sau serviciile noastre.

Principiile si liniile de actiune precizate constituie baza de referinta dupa care se stabilesc obiectivele si tintele de mediu pe care ni le propunem.

 - Compliance with the legal limits of noise level in the manufacturing sections and in the environment;
 - Educating, training, motivating employees to manage their activity in a responsible way towards the environment and implementing a proactive mentality regarding the environment;
- ➔ Prevention of possible risks and emergency situations.
- ➔ Acting towards the continuous improvement of our environmental performance and reducing the negative environmental impacts from our activities, processes, products or services.

The specified principles and lines of action represent the reference basis according to which the environmental objectives and targets that we propose are established.

It is the responsibility of management to ensure that this policy is known, understood, followed and maintained by all employees, at all levels of the organization.

Also, information on the environmental management system and its performance is available to all interested parties who request it.
